- 6. Sponsors & Acknowledgements:
 - a. **Referee Bursary Presentation** Olivia Wallis / Cordell Dickie Officials were chosen based on a points system. Al was in attendance to present Olivia Wallis with the Female Bursary. He had to leave back to work, so when Cordell arrived, he was presented his bursary by President Sarah Wallace.

Al has proposed that KWSL also help out with cost of mentoring of new referees, as currently it is fully funded by COYSA.

8. Open Issues:

- b. Co-Ed Year Wrap-up Sheila noted that there were 5 teams in Competitive, 9 in High Rec and 12 in Low Rec. Overall the tournament went well, and they are always taking suggestions and looking for ways to improve the tournament year after year.
 - Donations were made as follows: \$1500 to Okanagan Food Bank, and \$1500 to Inn from the Cold. Tentative dates for 2017 will be July 29th/30th. This will be the 10th Annual Tournament. More local teams represented would be great to see.
- c. Sunday Cup: revised format / incentives and/or prizes. Donna noted that there was a 65% participation rate (23 out of 35 teams) and the tournament concluded with 3 byes, 8 played games and 14 forfeits.
 - We are looking for suggestions and will be implementing changes for the upcoming year, as we hope that we can learn from this last season and make the Sunday Cup Tournament more successful this year.

Additional questions that were brought to the Executive: Individual asked if we would entertain a 40+ Masters Division. The exec responded that at this time we are still looking to fill the Masters Division that we currently have and not looking to create a second one at this time.
